of delivery, except as noted below. This warranty applies to single shift (standard 8-hour day, 5 days per week) use, and covers products delivered in the contiguous United States and Canada.

This warranty covers repairs or replacement of product at our discretion and payment of approved labor charges as necessary to affect such repairs or replacement.
